#### **EXHIBITOR TERMS AND CONDITIONS:**

#### **General Terms**

## **Eligibility:**

a. Exhibition opportunities are open to organizations and entities domicile in Botswana and international, that wants to contribute to sustainable energy initiatives in Botswana and the SADC region.

#### **Exhibitors Commitment**

- a. By agreeing to exhibit at the 2024 SADC Sustainable Energy Week, the exhibitor commits to fulfilling the financial and or service obligations specified in their chosen exhibition package.
- b. SACREEE reserves the right to alter the exhibition layout without notice.
- c. Complimentary passes cannot be used by any person, other than the person registered to exhibit will be allowed to access reception dinner, networking cocktail, and cultural dinner.

# **Application Process:**

- a. Interested exhibitors must complete the Exhibitors Application Form and submit it to the Event Manager for review and approval.
- b. The deadline to apply for exhibition is 30 October 2024

NB: Exhibitors are allocated on a first-come, first-served basis, subject to availability.

# **Payment Terms:**

- a. Full payment is required upon acceptance of the sponsorship application to confirm the exhibition.
- b. Payment methods include bank transfer, credit card, or other approved methods as specified by SACREEE.

NB: All payments must be made within 30 days of invoice issuance.

## **Non-Compete Clause:**

a. Exhibitors must respect the exclusivity agreements for certain sponsorship categories and refrain from promoting competing products or services during the event.

## **Cancellation and Refund Policy:**

- a. Exhibitors may cancel their exhibition in writing. Refunds will be issued based on the date of cancellation:
  - i. 100% refund if cancelled 90 days before the event.
  - ii. 50% refund if cancelled 60 days before the event.
  - iii. No refund if cancelled less than 60 days before the event.



NB: The event organisers reserve the right to cancel the event. In such cases, exhibitors will receive a full refund.

# **Liability and Indemnity**

- a. Liability: The event organizers are not liable for any loss, damage, or injury incurred by exhibitor or their representatives during the event, except where such loss, damage, or injury is caused by the negligence of the organizers.
- b. Indemnity: exhibitor agree to indemnify and hold harmless the event organizers against any claims, damages, liabilities, and expenses arising out of or related to the exhibitor's participation in the event.

#### **Amendments:**

- a. Changes to Terms: The event organizers reserve the right to amend these terms and conditions at any time. Sponsors will be notified of any changes, and continued participation in the event will constitute acceptance of the revised terms.
- b. Force Majeure: In the event of circumstances beyond the control of the event organizers (e.g., natural disasters, pandemics), the organizers reserve the right to cancel or reschedule the event. Sponsors will be notified promptly of any changes.
