### **SPONSORSHIP TERMS AND CONDITIONS**

#### **General Terms**

#### 1. Eligibility:

1.1 Sponsorship opportunities are open to organizations and entities domicile in Botswana and international, that wants to contribute to sustainable energy initiatives in Botswana and the SADC region.

#### 2. Sponsorship Commitment

2.1 By agreeing to sponsor the 2024 SADC Sustainable Energy Week, the sponsor commits to fulfilling the financial and/or service obligations specified in their chosen sponsorship package.

#### **3. Application Process:**

3.1 Interested sponsors must complete the Sponsorship Application Form and submit it to the Event Organiser for review and approval.

3.2 The deadline to apply for sponsorship is 30 January 2025.

### NB: Interested sponsors should act quickly to secure their space, as availability is limited and will be allocated on a first-come, first-served basis.

#### 4. Payment Terms:

4.1 Full payment is required upon acceptance of the sponsorship application to confirm the sponsorship.

4.2 Payment methods include bank transfer, credit card, or other approved methods as specified by SACREEE.

#### NB: All payments must be made within 30 days of invoice issuance.

#### 5. Non-Compete Clause:

5.1 Sponsors must respect the exclusivity agreements for certain sponsorship categories and refrain from promoting competing products or services during the event.

#### 6. Cancellation and Refund Policy:

6.1 Sponsors may cancel their sponsorship in writing. Refunds will be issued based on the date of cancellation:

- 6.1.1 100% refund if cancelled 90 days before the event.
- 6.1.2 50% refund if cancelled 60 days before the event.

6.1.3 No refund if cancelled less than 60 days before the event.

### NB: The event organisers reserve the right to cancel the event. In such cases, sponsors will receive a full refund.



#### 7. Liability and Indemnity

7.1 Liability: The event organizers are not liable for any loss, damage, or injury incurred by sponsors or their representatives during the event, except where such loss, damage, or injury is caused by the negligence of the organizers.

7.2 Indemnity: Sponsors agree to indemnify and hold harmless the event organizers against any claims, damages, liabilities, and expenses arising out of or related to the sponsor's participation in the event.

#### 8. Amendments:

8.1 Changes to Terms: The event organizers reserve the right to amend these terms and conditions at any time. Sponsors will be notified of any changes, and continued participation in the event will constitute acceptance of the revised terms.

8.2 Force Majeure: In the event of circumstances beyond the control of the event organizers (e.g., natural disasters, pandemics), the organizers reserve the right to cancel or reschedule the event. Sponsors will be notified promptly of any changes.

#### 9. Use of Intellectual Property:

9.1 The Sponsor grants the Organizers the right to use the Sponsor's logos, trademarks, and other intellectual property for the purposes of promoting the event and fulfilling the sponsorship obligations.
